COURTESY PARKING (Part 2 of 3)

Courtesy Parking is WBCCI's best kept secret – and it is one we *don't want* to keep! Some members use Courtesy Parking as they travel. They use it to visit members in another part of the state. The International Directory and our Unit Directory list Courtesy Parking opportunities.

Here are some stories from Idaho members who offer this treat.

Mike and Lucille Allen - Garden Valley, ID We checked YES on CP for many years, but only had one AS take us up on it, and that was last spring. They camped for one night with a fabulous view of Garden Mountain, here in Garden Valley, Idaho. We do not have hookups, but do have 110 available if the camper has a 100' cord. We only accept Airstreamers, and if they aren't in the Club, they wouldn't know about us in the first place. We are a little off the beaten path, but a mountain community with a lot to offer. Being 50 miles north of Boise, makes Garden Valley the closest recreation getaway location. (Photo provided by Mike Allen)



Ray and Sherry Hoem - Buhl, ID We have had Airstreamers call and ask us about parking here and we have explained we have both electricity and they can be hooked up as well. And we have had many trailers stay here but NONE of them were Airstreams. I guess we travel in a different crowd - however, on the other side, we have checked for parking and decided not to go there - but we called and let the people know we weren't coming!

Terry & Cindi Little - Boise, ID We only had two calls in a year's time, both of which were for much larger trailers than our property can handle. Unfortunately, it's a lovely setting for campers, up in the Boise mountains, but any trailer over 20' won't be able to get back up our driveway.

Deb & Shane Compton - Boise, ID We do offer courtesy parking but have never been approached. We also belong to Boondockers - a similar situation. We offer people courtesy parking. We have had several guests through Boondockers. We offer parking and 15 amp service. The cool part about Boondockers is that you can see references from previous hosts. It's nice to know who is in your yard. We don't limit stays. We have heard of problems when hosts offer all utilities and Wifi - they get working travelers - it's been frustrating that the Boondocker is earning money while the host covers their rent and utilities.

David & Linda Johnson - Post Falls, ID Since we joined in 2017, we have only had our CP used one time for one night with someone passing through our area after a Rally that we had jointly attended. In all of our travels we have yet to use the Courtesy Parking. The problem that I see is that there is no way of distinguishing what type of parking is to be provided other than calling and asking. For instance, if you're traveling in the summer and need 30amp for air conditioning, it would be helpful to know if it is provided by looking at the site.

Our Courtesy Parking includes 30 amp and water with plenty of room for access but most people are unaware without calling. Our biggest concern, because of our location in the Coeur d'Alene area, was that we would be bombarded with requests. That certainly has not been the case. However, we have just been contacted by some travelers out of Utah that will be in our area this next summer and would like to stay a few days.

Jan & Frank Roman - Boise, ID Yes we can do the courtesy parking (for Airstreams) and can offer hookups, however 1 or 2 nights would be max.

Jim & Susie Borowicz - Elk City, ID We've been on the CP list now for 2 years and so far....no one has come up.

If you cancel, rally deposits are refunded to the extent that the Unit does not have to pay the costs.

- Pre-paid activity reservations or expenses may be non-refundable.

State Park camp sites have water and electricity, but no sewer hookups. A dump station is available.

Executive Committee Report

Executive Committee Report Follow-up to August 2019 General Meeting, Recommendations and Changes

During the August 2019 Executive and General Business Meetings, Mim Davidson presented a request, in follow-up to frustrations with State Park processes with Reserve America, that the club evaluate a club/debit card for with rally reservations and a need to determine a method to address non-refundable changes that currently can't be assigned to a person and/or accrued as part of rally planning.

Lively discussion ideas included: a unanimous decision that rally participants should not pay for expenses due to reservation process, a process needs to be determined for cancellations by implementation of a non-refundable charge at registration, bring back the round up to nearest dollar, set limits for registrations and insure that Club costs (storage units) are considered in pricing for rally fees. Agreed that the Executive Committee would discuss at the October meeting and determine options that would be shared with all members and go to a vote at the April 2020 Meeting.

At the October Executive Board meeting a Credit Card Committee was established. The group included Larry Conn, Treasurer, Lucky De La Pena, Trustee, Larry Warren 1st VP and Bill Sargent, President.

The sub-committee met for over 6 hours to address the concerns that required a review of the entire rally process, which drives most of the Club's financial activity. Communication to other members of the Executive Board was on-going.

The issue at the core of the rally process is cash flow. This is because RV parks are requiring larger deposits than before, and, to guarantee our campsites, we need to reserve earlier than before. State parks don't take deposits, they require 100% payment up front. This becomes a problem because rally registration fees are not paid until months after the deposits are paid out. Last year the Club had to cash in its Certificate of Deposit (normally held as a reserve) to pay rally deposits.

For example, this year there is a single rally deposit that took one third of the Club's working capital (the Club normally has about \$9,000 in working capital and \$3,000 in reserve). There are 5 rallies that still need to have their deposits funded this year.

The recommendations were presented to the Executive Board, voted on, and passed unanimously. The Credit Card Committee soon realized selected changes to financial processes need to be made in time for the 2020 Rally season.

The Idaho Unit Constitution Article V, Sections 2-4 provide the Executive Committee the "full administrative authority in all matters pertaining to the unit..." Based on this the following changes are in the process of implementation:

1. Obtain a credit card for club use. Normally, the Treasurer will maintain possession and control of the credit card; when the Treasurer is unavailable the President will have possession of the credit card.

The credit card will be used to book rally sites **only**. The process will be simple, the rally host makes all of the arrangements with the campsite, as they currently do, and then communicates those arrangements to the Treasurer who will then call the camp site and provide the credit card information. Club members will no longer have to use their personal credit cards for booking campsites once the Club credit card has been obtained.

2. To increase the Club's working capital and catch up with inflation, annual unit membership dues have been increased from \$15 per year to \$25 per year beginning in 2021. **Idaho Unit Bylaws, Article VII, Sec. 1 The annual Unit dues of Regular and Affiliate members shall be set by the Executive Board.**

Additionally, the following Executive Board approved changes will be presented to all members for input at the April 2020 General meeting.

Executive Committee Report (continued)

Changes to Rally Hosting

- A. A recommendation that rally hosts limit state park rallies to 12 units in order to limit cancellation fees. Members are free to make their own reservations and attend the rally if all 12 slots have already been filled.
- B. The rally fee round-up amount is increased from \$1.00 to \$5.00. This \$4.00 increase is to fund the increasing fees that the Club will incur with greater use of electronic financial transactions (e.g., PayPal and credit card fees).
- C. Member rally fees are to be PAID at time of REGISTRATION. No more collecting rally fees at the rally. Rally hosts will calculate total rally costs ahead of time, including campsite charges. There are two benefits to this change. First is price transparency, potential rally attendees can see exactly what the cost will be to attend a rally. Second is repayment to the Club's operating bank account sooner than the old system of collecting rally fees at the rally (a key change in reducing cash flow issues).
- D. The Executive Board, **under the authority of Article XI, Sec 1-2**, unanimously recommends the elimination of Article XIII, Idaho Bylaws, "free rally fee coupon" program.

Any outstanding coupons will be honored, but going forward, new members will not receive a "free rally fee coupon". The Board received a number of complaints about this program that fall into two types of complaints. The first type of complaint is that the term "free rally fee coupon" is deceptive; the term suggests attendance at a rally will be free, when actually the coupon covers only a fraction of the cost of attending a rally. Some members described the program as "bait and switch". The second type of complaint focused on the high cost of some rally fees. For those "high fee" rallies, the use of coupons by new members would put a significant financial burden on those rally attendees that did not have a coupon (the rally costs attributable to the coupon holder are shifted to all other rally attendees).

The club is also moving forward with Website changes. **Minutes from 8/25/2018 meeting noted that a motion to approve EFT/on-line changes was made by Charlie Burke and seconded by Peter Goedeking. Unanimously approved.**

- A. Online payments for the unit will take place through a secure PayPal account.
- B. Move to online registration renewals. No more paper forms, members renewing need to go to the website. For those members who are unable to go online, they need to contact the Treasurer and he/she will help them get renewed.
- C. Move affiliate registration and renewals to the unit's website as the functionality and training become available. For those folks who are unable to renew online, they can contact the Treasurer for help signing up or renewing.

Please send all comments or additional input to Ann Sargent, Secretary, frontrowannie@gmail.com. These will be compiled and shared prior to the April business meetings. The General Business meeting agenda will include discussion of these changes.

2020 will be a transition year for these changes. Please be patient while the Club moves these new processes forward and works through the inevitable bugs.

Do you have an Idaho State Parks Passport?

The Idaho State Parks Passport offers unlimited entrance to 28 state parks — *normally \$5 per vehicle per day* — and covers boat launch fees throughout Idaho's park system.

Idaho residents pay \$10 per vehicle, per year, for the passport. It is available when you register your vehicle online, by mail or at a county Department of Motor Vehicles office. It might be the best \$10 you ever spent!

If you don't live in Idaho, you can purchase a \$40 Motor Vehicle Entry Fee (MVEF) Annual sticker and receive unlimited access for overnight camping and day-use entrance to all of Idaho's beautiful state parks- **a savings of \$5 per day.**
